AKTA PERIHAL DAGANGAN 2011

PERINTAH PERIHAL DAGANGAN (PENANDAAN TOPI KELEDAR MOTOSIKAL) 2012

PADA menjalankan kuasa yang diberikan oleh perenggan 29(1)(b) Akta Perihal Dagangan 2011 [*Akta 730*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Perihal Dagangan (Penandaan Topi Keledar Motosikal) 2012**.

(2) Perintah ini mula berkuat kuasa pada 1 September 2012.



Tafsiran

2. Dalam Perintah ini, “topi keledar” ertinya topi keledar mengikut pengertian Kaedah-Kaedah Motosikal (Topi Keledar) 1973 [*P.U. (A) 43/1973*] dan yang telah mematuhi kehendak spesifikasi yang dinyatakan di bawah kaedah 3 Kaedah-Kaedah itu.

Penandaan topi keledar motosikal

3. Topi keledar motosikal yang dibekalkan atau ditawarkan untuk dibekalkan hendaklah mempunyai tanda yang dinyatakan dalam ruang (1) Jadual mengikut standard yang dinyatakan dalam ruang (2) Jadual, mengikut mana-mana yang berkenaan.

TRADE DESCRIPTIONS ACT 2011

TRADE DESCRIPTIONS (MARKING OF MOTORCYCLE SAFETY HELMET) ORDER 2012

IN exercise of the powers conferred by paragraph 29(1)(b) of the Trade Descriptions Act 2011 [*Act 730*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Trade Descriptions (Marking of Motorcycle Safety Helmet) Order 2012**.

(2) This Order comes into operation on 1 September 2012.



Interpretation

2. In this Order, “safety helmet” means a safety helmet within the meaning of the Motor-Cycles (Safety Helmets) Rules 1973 [*P.U. (A) 43/1973*] and has complied with specification requirements specified under rule 3 of the Rules.

Marking of motorcycle safety helmet

3. A motorcycle safety helmet supplied or offered for supply shall bear the mark specified in column (1) of the Schedule according to the standard specified in column (2) of the Schedule, as the case may be.

(1) Mark	(2) Standard
 XXXXX XXXXX – Approval number.	Malaysian Standard MS 1 – Protective Helmets and Visors for Vehicle Users – Specification.
 YYYYY X – Refers to the Country which recognizes the compliance of standard. YYYYY– Approval number.	United Nation Economic Commission for Europe Regulation 22 Uniform Provisions Concerning the Approval of Protective Helmets and of Their Visors for Drivers and Passengers of Motor Cycles and Mopeds.

Exemption

4. Motorcycle safety helmet used for test sampling is exempted from the application of this Order.
